Volunteer Requirements

- Volunteers must be 18 years of age or older, or:
 - a. be at least 16 years of age with a signed parental consent form and waiver.
 - b. if under 16 years of age, a parent must be trained and be an active volunteer before the minor is eligible for volunteer duties.
- Must complete a volunteer application and waiver.
- Must understand the potential human health hazards and should have a current tetanus vaccination, if applicable.
- Must understand the possible disease risk and should have current vaccinations for animals at home.
- Must understand B.A.S.S. policies and procedures and be able to follow directions.
- Must immediately report any injuries received while volunteering to a B.A.S.S. board member.
- Must report any problems he/she may have with policies or staff, so that we can work together as an effective team.
- Must not knowingly take actions against the wishes of the voting membership as a whole.
- Must be a reflection of the values and standards set by B.A.S.S. and should feel comfortable with our policies and procedures, including euthanasia.
- Should join the staff as a result of mutual interest and concern for the animals.
- Should report on time and complete his/her shift as expected or find appropriate substitute coverage. If coverage cannot be obtained, advanced notice is required to be given to the shelter's operations director.

Often people who care about the plight of homeless animals are overwhelmed by the enormity of the problem. It's true that no one person can save them all, but if you can make a difference in the life of even one animal, let alone hundreds each year, then your contribution is invaluable.

6 Terms and Conditions

1. I understand that Bloomingdale Regional Animal Shelter Society (B.A.S.S.) has the right to refuse or revoke membership for reasonable cause. I further understand that continued membership is contingent upon following all B.A.S.S. policies and procedures.
2. I fully understand the hazards of working with animals and the possibilities of injury or disease transmission to myself or my pets while performing any duties for B.A.S.S. In the event of my injury or illness, I agree to pay for all medical and other costs in their entirety.
3. I understand the increased potential of exposure to rabies and tetanus. As part of my preventative care, I agree to discuss these issues with my private physician, including discussing a current tetanus inoculation.
4. I am in good physical health and am able to handle the tasks assigned to me as a volunteer for B.A.S.S. I have listed any health problems or special considerations in Section 2 of this agreement.
5. I waive my right to legal action against B.A.S.S.
6. I understand that I will not qualify for voting membership until the required six (6) month probationary period is satisfactorily completed. Voting status also requires a minimum commitment of ten (10) volunteer hours or more per month.
7. I certify that I am 18 years of age or older, or if under 18 years, I understand that I do not qualify for voting membership status. I further understand that as a minor, my parent or legal guardian, whose signature appears below, is responsible for my actions while performing my volunteer duties for B.A.S.S.
